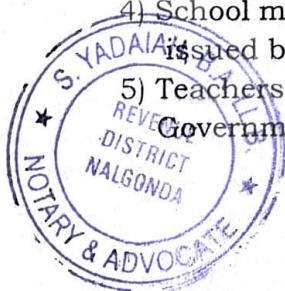

Prime) School (E.M) Cherlapalli (Gr.) Nalgonda (M) Nalgonda District for the academic year 2019-20 to 2028-29 for the first registration of classes (E.M) from the Government Orders Dated 7 to 10. After examining the proposals submitted along with the checklist, visit report and special report the following documents have been submitted as per the following items.

Having examined such proposals thoroughly, as per the Government Order from 10th to 7th, the District Education Officer, Nalgonda, under the jurisdiction of S.R. Prem (S.R.Prime) School (E.M.) Cherlapalli (1) Nalgonda (M) Nalgonda District, has issued the first recognition permission for the first recognition permission for the academic year 2019-20 to 2028-29. The following rules and regulations are hereby issued, directing the school to run in strict compliance with the rules and regulations mentioned below.

- 1) The school management shall operate the school in accordance with the regulations issued by the Government or the relevant authority from time to time.
- 2) The school should take steps to provide education to all students in the area.
- 3) The management of this school must follow the syllabus/curriculum issued by the Telangana Government.
- 4) School management should follow the school time table, holidays and holidays issued by the Telangana Government.
- 5) Teachers with appropriate education qualifications as specified in the Government Order in Note 1 should be appointed only on the stop pattern.

- 6) The School - related result should be satisfactory.
- 7) The School management should submit the records and accounts to the District Education Officer, Nalgonda by September 30th of every academic year for verification.
- 8) The School Governing body should decide the salary and wages and approve them every year by the District Education officer.
- 9) The provisions of all Government Orders not included in these orders regarding School recognition should also be following.
- 10) All the chairs not registered in the orders in accordance with the 110 School code should be collected only with the approval of the Governing body.
- 11) The School owner shall close the school only after giving at least on month's prior notice to the parents and the supervising officer and to the District Education Officer.
- 12) The School should be closed only from the day the summer vacation begins unless the permission of the relevant authority has been obtained for the closure of the school.
- 13) Proposals for recognition by the school management should be submitted at least 6 Months before the expiry of the current recognition period.
- 14) The name of the school should be registered with the District Common Examination Board. The working hours of the schools term holidays, especially Dussehra, Sankranti and second Saturday, as per the regulations of the Telangana Government should be strictly followed.
- 15) Medical examination should be conducted for students every year.
- 16) The School owners shall operate the school in accordance with the government regulations and in accordance with orders.






2. That the society shall abide to the rules and regulations made in the Govt. Orders 1st cited and subsequent orders.
